COVID STATEMENT FOR SARA HALL

- 1. Anyone testing positive with COVID-19 or anyone with COVID-19 symptoms must not enter SARA Hall.
- 2. SARA Hall should be kept well ventilated during all sessions; opening doors and windows even for a short period can help to refresh the air and reduce COVID-19 particles. (Note: wall vents are fixed in the open position)
- 3. Clean surfaces that people touch regularly (Blue cleaning roll and surface sprays are provided)
- 4. Clean hands regularly (handwash and paper towels are available in the two cloakrooms) we encourage session leaders to supply hand sanitiser and/or ask session attendees to bring their own.
