More about SARA

Sudley Area Residents' Association was established in 1977 and registered as a charity in 1979. The Association is a focus group for a large area of Aigburth in South Liverpool and operates from SARA Hall.

We work with statutory and voluntary bodies, interested groups and individuals in a common effort to promote the area in which we live.

SARA Hall is a community hub with over 32 hours of weekly sessions for all age groups. We have a number of monthly sessions at the weekend including a variety of workshops, a Councillor's surgery and an early-years play session. We run a variety of social and fundraising events throughout the year including quiz nights, bingo, our monthly community cinema, various lectures and a festive evening to end the year.

We have recently been left with no option but to stop hiring the hall for children's birthday parties. This decision wasn't taken lightly but because (i) a good proportion of hirers do not leave the building in good order, and (ii) we don't have the volunteers to check the building after all children's parties.

We run a number of day trips throughout the year.

Each year we have a charity of the year where a large proportion of our fundraising efforts go. In the last 15 years, we've raised over £19,000 for local good causes.


